Items of Interest

E-Manifest / ACES **Documentation** In Truck Cameras **Selection and Searches Transponder or Fees Border Security Issues Other Crossing Issues**

E-Manifest / ACI

- E-Manifest
 - Carrier Code
 - E-Manifest Portal access or use service provider
 - CRN must be submitted 60 minutes prior to arrival
 - Present approved Lead Sheet at the border

Documentation

- Minimum requirement is a Lead Sheet
 - If all information is entered properly and is released that is all that is needed
- Bills of lading, invoices, manifests can all help with processing, if needed
- Contract if hauling on behalf of another carrier (using their Carrier Code)
 - It is far better to have supporting documents and not need them than it is to arrive at the border and be "Not on File" and paperwork is needed for the broker.



In Truck Cameras / Dash Cams

- Canada
 - Generally permitted unless they hinder or obstruct the officer
 - May be subject to examination
 - Footage or photos should not be deleted by officers



Selection and Searches at the Border

- Dual Mandate
 - Facilitate legitimate travellers and trade while intercepting contraband and detecting immigration and trade offenses
- Commercial stream
 - 2 components
 - Driver
 - Goods
- Reasons for examination
 - Random
 - Regulatory
 - Contraband



Other Government Department Considerations

- CBSA administers 90 pieces of legislation on behalf of several OGDs.
- Canada Food Inspection Agency, Health Canada are the most common, and Transport Canada are the most frequent.



Transponder or Fees

- Canada Bound
 - No Transponder or crossing fees in the Atlantic region

Border Security Issues

- Trade Chain Partners can help secure the border
 - Partners in Protection (PIP)
 - Customs Trade Partnership Against Terrorism (C-TPAT)
 - Mutual recognition
- Trusted Traveller program membership
 - FAST
 - NEXUS
 - CDRP (Canadian)
 - There have been instances where criminal enterprises have recruited FAST members specifically because they are members

- CBSA Border Watch Line
- Anonymously report suspicious cross border activities
- From Canada and the USA
- Toll-free: 1-888-502-9060
- Information provided is confidential. Calls to the Border Watch Line are anonymous and are not recorded. You are not required to provide your name and/or telephone number.
